The promoter shall deposit seventy percent of the amounts realized by the promoter in a seperate escrow account to be maintained in a schedule bank to cover the cost of construction and the land cost to be used only for that purpose as per sub-clause (D) of clause (1) and sub-section (2) of section 4 of the Act;
- iv. The promoter shall comply with all the functions and duties as per section 11 of the Act and shall upload Quarterly status updates of the project within 30 days from the end of each quarter;
