- (iv) The registration shall be valid from <u>04-02-2019</u> and ending with <u>11-04-2021</u> unless renewed by the Real Estate Regulatory Authority in accordance with section 6 of the Real Estate (Regulation & Development) Act, 2016 read with Rule 7 of Karnataka Real Estate (Regulation & Development) Rules, 2017.
