 - (iv) The registration shall be valid from <u>04-08-2017</u> and ending with <u>31-03-2019</u> unless renewed by the Real Estate Regulatory Authority in accordance with section 6 of the Real Estate (Regulation & Development) Act, 2016 read with Rule 7 of Karnataka Real Estate (Regulation & Development) Rules, 2017. This certificate is valid till the ending date mentioned above;
 - (v) The promoter shall comply with the provisions of the Real Estate (Regulation & Development) Act, 2016 and the
 Karnataka Real Estate (Regulation & Development) Rules, 2017 and regulations made thereunder;
 - (vi) The promoter shall not contravene the provisions of any other law for the time being in force in the area where the project is being developed.
