This Appeal is filed under Section 44 of the Real Estate (Regulation and Development) Act, 2016 before the Karnataka Appellate Tribunal, Bengaluru, to set aside the order dated 29<sup>th</sup> July 2019 in CMP/190225/0002281 passed by the Adjudicating Officer, RERA Respondent-3. This appeal was transferred to this Tribunal on 02.01.2020 and renumbered as Appeal No.(K-REAT) 162/2020.

This appeal coming on for orders this day, the Chairman, made the following:

#### **JUDGMENT**

This appeal is listed today for orders on office objections.

At this stage, Sri M V Prashanth, learned Counsel for 3<sup>rd</sup> Respondent submits that the Appellant has preferred this appeal challenging the order passed by the Adjudicating Officer wherein the learned Adjudicating Officer has rejected the application filed by the appellant under Section 8(1) of the Arbitration and Conciliation Act,

1996 and held that the complaint filed by the complainant-Respondents No.1 & 2 herein is maintainable.

Sri M.V. Prashanth, learned counsel for the 3<sup>rd</sup> Respondent further submits that the matter is already covered by an earlier Judgment of this Hon'ble Tribunal dated 08.01.2020 in APPEAL (K-REAT) NO.126/2020 (OLD RERA APPEAL NO.164 OF 2019) and prays for dismissal of the appeal.

In view of our earlier Judgment dated 08.01.2020 passed in APPEAL (K-REAT) NO.126/2020 (OLD RERA APPEAL NO.164 of 2019) (Parkway Homes LLP Vs. Vishaka Priyadarshini and another) this appeal does not survive for consideration and is, accordingly, dismissed.
