This Appeal is filed under Section 44 of the Real Estate (Regulation and Development) Act, 2016 before the Karnataka Appellate Tribunal, Bengaluru, to set aside the order dated 28<sup>th</sup> August, 2018 in CMP/171027/0000168 passed by the Adjudicating Officer, RERA Respondent. This appeal was transferred to this Tribunal on 02.01.2020 and renumbered as Appeal No.(K-REAT) 51/2020.

This appeal coming on for further hearing this day, delivered the following judgment:

#### **JUDGMENT**

There is no representation for appellant as well as Respondent No.2.

Memo of appearance filed by Sri S. N. Ashwathnarayan to appear on behalf of RERA-R1 is taken on record.

The appellant being partly aggrieved by the order dated 28.8.2018 passed in case No.CMP/171027/0000168 by RERA, Bangalore, directing the 2<sup>nd</sup> Respondent/Developer to return Rs.13 lakhs to the appellant which was received by him within 60 days from the date of the order with interest at 10.25% p.a. from 61<sup>st</sup> day till the date of payment had preferred this appeal before the Interim Tribunal (KAT) on 24.4.2019 praying to direct Respondent No. 2 to

pay Rs. 13,00,000/- to the appellant along with damages and interest from the date of payment till realization.

Since the date of filing of the appeal, till date, appellant has neither furnished the process fee nor appeared before the Tribunal. The order sheet dated 8.1.2020, 28.1.2020, 5.3.2020 and 1.6.2020 would clearly show that the appellant has no interest in prosecuting the appeal.

In view of the above, the appeal is dismissed for nonprosecution.
