#### **Execution Order:**

#### CMP 4651

Complaint under Section 31 of RERA Act has been initiated by the complainant Mrs.Haritha Krishna Vijapurapu who is the buyer under the project "ND Passion Elite" which is developed by "ND Developers Private Limited.," This complaint was filed by the complainant claiming delay compensation. After hearing the parties, order was passed on 09/09/2020 by directing the developer to pay delay compensation on the amount paid by the complainant @9% per annum commencing from July 2015 till 30-04-2017 further the developer is also directed to pay interest @2% above the MCLR of SBI From 01/05/2017 till the execution of sale deed with Occupancy Certificate.

The developer is also directed to pay Rs.5000/- as cost of this case.

The complainant has calculated the amount paid by him. According to him from 30/06/2015 to 08/02/2017 he had paid total amount to the builder is Rs.76,32,558/- from 30/06/2015 to 30/04/2017 he as calculated on the respective amount paid on respective dates with interest of @ 9% per annum on the said amount, which interest totally comes to Rs.8,38,267/-.

The complainant has calculated the amount paid by him was on 01/05/2017 is Rs.76,32,558/,with interest @ 10.45% per annum above the MCLR of SBI on the said amount paid by him from 01/05/2017 to 30/11/2020 which comes to Rs.28,60,442/-.

The complainant further he has calculated the amount paid by him was on 19/05/2017 is Rs.9,14,853/,with interest @ 10.45% per annum above the MCLR of SBI on

The complainant has given a representation with memo of calculation since the developer failed to comply with

the same. There is no appeal. Objections called for but not filed.

As per Rule 25 of the Karnataka Real Estate (Regulation and Development) Rules, 2017 the recovery of the amount due is to be considered as arrears of land revenue. In support of the same the authority is taking the shelter under Section 40 of the RERA Act which reads as follows:

Sec 40(1): "if a promoter or an allottee of a real estate agent, as the case may be, fails to pay any interest or penalty or compensation imposed on him, by the adjudicating officer or the regulatory authority or the appellate authority, as the case may be, under this Act or the rules and regulations made there under, it shall be recoverable from such promoter or allottee or real estate agent, in such manner as may be prescribed as an arrears of land revenue"
