Execution Order:

CMP 1175

Complaint under Section 31 of RERA Act has been initiated by the complainant Mr.Kolige Madhusudan who is the buyer under the project "Provident Sunworth" which is developed by "Provident Housing Pvt. Ltd.," This complaint was filed by the complainant claiming delay compensation. After hearing the parties, order was passed on 03/08/2020 by directing the developer to pay delay compensation on the total amount paid by the complainant in form of simple interest @9% per annum from the date of due date till 30/04/2017 and @ 2 above the MCLR of SBI commencing from 01/05/2017 till the possession is delivered.

The complainant calculated the total amount paid by him from 28/06/2016 is Rs.35,62,629/- with interest @ 9% per annum on the said amount paid by him from 28/06/2016 to 30/04/2017 which comes to Rs.3,75,100/-.

The complainant calculated the total amount paid by him from 01/05/2017 is Rs.35,62,629/- with interest @9.30% (@2% above the MCLR of SBI) per annum on the said amount paid by him from 28/06/2016 to 03/01/2020 which comes to Rs.8,86,860/-.

amount paid by him from 28/06/2016 to 03/01/2020 which comes to Rs.8,86,860/-.

Therefore the total interest payable by the developer from 25/03/2018 to till 31/12/2020 Rs.12,61,960/-.

Total amount due from the developer is Rs.12,61,960/-.

The complainant has given a representation with memo of calculation since the developer failed to comply with the same. There is no appeal. Objections called for but not filed.

As per Rule 25 of the Karnataka Real Estate (Regulation and Development) Rules, 2017 the recovery of the amount due is to be considered as arrears of land revenue. In support of the same the authority is taking the shelter under Section 40 of the RERA Act which reads as follows;

Sec 40(1): "if a promoter or an allottee of a real estate agent, as the case may be, fails to pay any interest or penalty or compensation imposed on him, by the adjudicating officer or the regulatory authority or the appellate authority, as the case may be, under this Act or the rules and regulations made there under, it shall be recoverable from such promoter or allottee or real estate agent, in such manner as may be prescribed as an arrears of land revenue"
