### **Execution Order:**

#### **CMP 3083**

Complaint under Section 31 of RERA Act has been initiated by the complainant Mr.Shahid Iqubal who is the buyer under the project "Golden Panorama" which is developed by "Golden Gate Properties Limited.," This complaint was filed by the complainant claiming delay compensation. After hearing the parties, order was passed on 09/08/2019 by directing the developer to pay delay compensation @9% per annum on the respective amount commencing from November 2016 till 30/04/2017 and @10.75% on the total amount paid by him commencing from 01/05/2017 till flat is officially handed over to the complainant.

The developer is also directed to pay Rs.5000/- as cost of this case.

The complainant has calculated the total amount paid by him was on 01/11/2016 is Rs.46,66,685/-from 01/11/2016 to 30/04/2017 with interest of @9% per annum on the said amount which interest totally comes to Rs.2,07,124/-.

The complainant has calculated the amount paid by him from 01/05/2017 is Rs.46,66,685/,with interest @10.75% per annum above the MCLR of SBI on the said amount paid by him from 01/05/2017 to 31/01/2021 which comes to Rs.18,84,350/-.

In support of the same the authority is taking the shelter under Section 40 of the RERA Act which reads as follows;  Sec 40(1): "if a promoter or an allottee of a real estate agent, as the case may be, fails to pay any interest or penalty or compensation imposed on him, by the adjudicating officer or the regulatory authority or the appellate authority, as the case may be, under this Act or the rules and regulations made there under, it shall be recoverable from such promoter or allottee or real estate agent, in such manner as may be prescribed as an arrears of land revenue"  When Sec. 40 read with Rule 25, the Deputy Commissioner is empowered to execute the order dated 23/11/2020 considering this amount as arrears of land revenue and has to be recovered
