Execution Order:

CMP 4324

Complaint under Section 31 of RERA Act has been initiated by the complainant Mr.Sreejit Nair who is the buyer under the project "ND Passion Elite" which is developed by "ND Developers Private Limited.," This complaint was filed by the complainant claiming delay compensation. After hearing the parties, order was passed on 09/09/2020 by directing the developer to pay delay compensation on the amount paid by the complainant with simple interest @2% above the MCLR of SBI commencing from May 2018 till the execution of sale deed with Occupancy Certificate.

The developer is also directed to pay Rs.5000/- as cost of this case.

The complainant has calculated the amount paid by him was on 01/05/2018 is Rs.95,49,240/-with interest @ 10.45% per annum above the MCLR of SBI on the said amount paid by him from 01/05/2018 to 30/11/2020 which comes to Rs.25,83,592/-.

Therefore the total interest payable by the developer from 01/05/2018 to till 30/11/2020 Rs.25,83,592/-.

Total amount due from the developer is Rs.25,89,592/-.

The complainant has given a representation with memo of calculation since the developer failed to comply with the same. There is no appeal. Objections called for but not filed.
