Complaint under Section 31 of RERA Act has been initiated by the complainant Mrs. Chandana Dileep And Ganesh Ravindra who is the buyer under the project "GM INFINITE SILVER SPRING FIELD" which is developed by "M/s.GM Infinite Dwelling (India) Private Limited.," This complaint was filed by the complainant claiming delay compensation. After hearing the parties, order was passed on 23/11/2020 by directing the developer to pay delay compensation simple interest @2%above the MCLR of SBI on the principle amount paid on the sale deed till the date of receipt of occupancy certificate.

The developer is also directed to pay Rs.5000/- as cost of this case.

The complainant has calculated the amount paid by him from 05/08/2017 is Rs.56,23,748 /- with interest @9.30% per annum above the MCLR of SBI on the said amount paid by him from 05/08/2017 to 28/02/2021 which comes to Rs.18,68,502/-.

Therefore the total interest payable by the developer from 05/08/2017 to 28/02/2021 is Rs.18,68,502/-.

Total amount due from the developer is Rs.18,73,502/-.

The complainant has given a representation with memo of calculation since the developer failed to comply with the same. There is no appeal. Objections called for but not filed.

	As per Rule 25 of the Karnataka Real Estate (Regulation and Development) Rules, 2017 the recovery of the amount due is to be considered as arrears of land revenue. In support of the same the authority is taking the shelter under Section 40 of the RERA Act which reads as follows;
	Sec 40(1): "if a promoter or an allottee of a real estate agent, as the case may be, fails to pay any interest or penalty or compensation imposed on him, by the adjudicating officer or the regulatory authority or the appellate authority, as the case may be, under this Act or the rules and regulations made there under, it shall be recoverable from such promoter or allottee or real estate agent, in such manner as may be prescribed as an arrears of land revenue"
	When Sec. 40 read with Rule 25, the Deputy Commissioner is empowered to execute the order dated 23/11/2020 considering this amount as arrears of land revenue and has to be recovered from the developer. Hence the following ORDER
	By acting under Section 40 of the RERA Act, read with Rule 25, the amount payable of Rs. Rs.18,73,502/- which is treated as arrears of land revenue from the developer "M/s.GM Infinite Dwelling (India) Private Limited.," and the same has to be recovered by sending the file to Deputy Commissioner for recovery as arrears of land

revenue. The same amount shall be deposited in

the office Account.
