### **Execution Order :**

#### **CMP 4979**

Complaint under Section 31 of RERA Act has been initiated by the complainant Mr.Yogita And Mr.Anand D who is the buyer under the project "GM INFINITE SILVER SPRING FIELD" which is developed by "M/s.GM Infinite Dwelling (India) Private Limited.," This complaint was filed by the complainant claiming delay compensation. After hearing the parties, order was passed on 23/11/2020 by directing the developer to pay delay compensation on the amount paid by the complainant @2%above the MCLR of SBI on the principle amount paid on the sale deed commencing from March 2017 till the date of receipt of occupancy certificate.

The developer is also directed to pay Rs.5000/- as cost of this case.

The complainant has calculated the amount paid by him from 01/04/2017 is Rs.43,57,072/.,with interest @9.30% per annum above the MCLR of SBI on the said amount paid by him from 01/04/2017 to 19/01/2018 which comes to Rs.3,26,386/-.

The complainant has calculated the amount paid by him from 20/01/2018 is Rs.54,75,000/.,with interest @9.30% per annum above the MCLR of SBI on the said amount paid by him from 20/01/2018 to 28/02/2021 which comes to Rs.15,84,720/-.

Therefore the total interest payable by the developer from 01/04/2017 to 28/02/2021 is Rs.19,11,106/-.

Total amount due from the developer is Rs.19,16,106/-.

The complainant has given a representation with memo of calculation since the developer failed to comply with the same. There is no appeal. Objections called for but not filed.

As per Rule 25 of the Karnataka Real Estate (Regulation and Development) Rules, 2017 the recovery of the amount due is to be considered as arrears of land revenue. In support of the same the authority is taking the shelter under Section 40 of the RERA Act which reads as follows;

Sec 40(1): "if a promoter or an allottee of a real estate agent, as the case may be, fails to pay any interest or penalty or compensation imposed on him, by the adjudicating officer or the regulatory authority or the appellate authority, as the case may be, under this Act or the rules and regulations made there under, it shall be recoverable from such promoter or allottee or real estate agent, in such manner as may be prescribed as an arrears of land revenue"

### ORDER

Rs.19,16,106/- which is treated as arrears of land revenue from the developer "M/s.GM Infinite Dwelling (India) Private Limited.," and the same has to be recovered by sending the file to Deputy Commissioner for recovery as arrears of land revenue. The same amount shall be deposited in the office Account.

The above amount has been calculated up to 28/02/2021.

a. As to the recovery of future interest on the amount of Rs.54,75,000/- @9.30% p.a. simple interest whenever it falls due, from 1<sup>st</sup> March 2021 to till realization.
