Applicant-Promoter, **M/S Golden Valley Developers**, applied for registration on 15.10.2017 for a Project namely **"GOLDEN VALLEY-PHASE 2"** and the Authority issued an Ack. On verification of the application, it was noticed that the applicant had not submitted all the required documents as per Sec.4 read with Rule 3 of Karnataka Real Estate (Regulation and Development) Rules 2017.

Since there were no compliances to the notices, the case was posted for final hearing on 09.09.2021.

The Applicant-Promoter has failed to appear on the date of hearing. Despite availing opportunities, the Applicant-Promoter has failed to submit the
