The developer Mantri Technology Constellations Private Limited, Bengaluru has registered his project "Mantri Manyata Energia" with RFRA having registration No. as PRM/KA/RERA/1251/309/PR/171014/000439. The promoter's representative had informed the Authority and the allottees who were preset about their application for Swamih Investment Fund – 1 to construct and complete the project.

On 22/10/2021 the promoter has alled an application that the project has been identified as a stalled project by Government of India through Swamih Investment Fund – 1 in its letter dated 17/09/2021. It is stated that an amount of Re. 17.1 Crores and additional amount Rs. 70 Crores has been approved and a copy of the letter issued by Swamih Investment Fund – 1 has been enclosed along with the application.

- The amount spent on the project during each month and the cumulative amount spent shall be declared. This shall be certified by a
