Applicant-Promoter, **SUMANGALA NAGARI** applied for registration on 20.11.2017 for a Project namely **"DEVI BUILDERS"** and the Authority issued an Ack. No. **PR/KN/171120/002385**. On verification of the application, it was noticed that the applicant had not submitted all the required documents as per Sec.4 read with Rule 3 of Karnataka Real Estate (Regulation and Development) Rules 2017.

The Authority has given opportunities to the promoter by releasing temporary login to furnish the requisite documents online on various dates i.e., 08.01.2018, 02.03.2018, 25.04.2018, 05.05.2018, 17.05.2018, 24.07.2018, 09.08.2018, 31.08.2019, 15.09.2018, 21.03.2019, 28.03.2019, 24.12.2019, 29.12.2020 and 13.07.2021. Since there were no compliances to the notices, the case was posted for final hearing on 21.10.2021.

The Applicant-Promoter has failed to appear on the date of hearing. Despite availing opportunities, the Applicant-Promoter has failed to submit the documents and information as required to comply with the procedure for Registration of the Project, in terms of Sec.4 of the Act read with Rule 3 of the Rules. Hence the following order is passed.
