Complaint under Section 31 of RERA Act has been initiated by the complainant Mrs.M P Geetha who is the buyer under the project "KRISNA LABURNUM" which is developed by "Dr.K. Balaraman" This complaint was filed by the complainant claiming Delay Compensation. After hearing the parties, order was passed on 25/06/2020 by directing the developer to pay interest @ 2% above the MCLR of SBI commencing from 01/07/2018 till possession is delivered after obtaining Occupancy certificate with all amenities.

The developer is also directed to pay Rs.5,000/- as cost of this petition.

The complainant has calculated for the amount paid by him was on Rs.1,71,58,700/-,with interest @9.3% p.a. on the said amount paid by him commencing from 01/07/2018 to 24/09/2021 which totally comes to Rs.56,62,935/-.

Total amount due from the developer is Rs.56,67,935/-.

The complainant has given a representation with memo of calculation since the developer failed to comply with the same. There is no appeal.

As per Rule 25 of the Karnataka Real Estate (Regulation and Development) Rules, 2017 the recovery of the amount due is to be considered as arrears of land revenue. In support of the same the
