The Authority has given opportunities to the promoter by releasing temporary login to furnish the requisite documents online on various dates i.e., 31.10.2019, 08.01.2020, 15.02.2020, 08.05.2020, 29.08.2020 and 07.08.2021. Since there were no compliances to the notices, the case was posted for final hearing on 21.10.2021.
