On verification, it was found that the applicant has not uploaded affidavit as per Section 3(1) of RERA Act, financial documents, project head details, commencement certificate, NOCs from various authorities, sanctioned plan, plan licence letter, specification and reasons for delay in registration of the project for 3 years on the portal. Notices were sent to the promoter on 28/2/2019, 7/4/2019, 28/5/2019, 9/9/2020 and 3/8/2021 for complying with the queries raised therein. Despite several opportunities, the promoter failed to comply with the queries as required.
