M/s Cronos Constructions had filed an application dated 17/10/2017 under Section 5(1) of the Real Estate (Regulation and Development) Act, 2016 for registration of the project "ALCON STAR" to which Acknowledgment number was allotted as **PR/KN/171017/002238**.

On verification, it was found that the applicant has not paid balance fee of Rs.22,080/- and not uploaded RTC/Khata, conversion order, sale deed, JDA, EC, Form-B, joint affidavit, approved plan & licence letter and NOCs from various authorities on the portal. Notices were sent to the promoter on 8/11/2017, 12/12/2017, 5/1/2018, 21/3/2018, 28/3/2018, 3/4/2018, 6/4/2018, 26/6/2019, 24/12/2019, 29/12/2020 and 13/7/2021 for complying with the queries raised therein. Despite several opportunities, the promoter failed to comply with the queries as required.

Registration fee is forfeited.
