On verification, it was found that the applicant has not uploaded project details, bank account name, sale deed in the name of present owners and EC on the portal. Notices were sent to the promoter on 20/8/2020, 8/9/2020, 18/9/2020, 16/10/2020, 27/10/2020, 21/12/2020 and 6/9/2021 for complying with the queries raised therein. Despite several opportunities, the promoter failed to comply with the queries as required.

Hence, final notice for hearing on 12/11/2021 was sent to the promoter on 10/11/2021, as to why this application should not be rejected and an
