Notices were sent to the promoter on 1/9/2020, 16/10/2020, 4/11/2020, 17/11/2020, 21/12/2020 and 6/9/2021 for complying with the queries raised therein. Despite several opportunities, the promoter failed to comply with the queries as required.
