M/s JD Blossoms had filed an application dated 7/8/2020 under Section 5(1) of the Real Estate (Regulation and Development) Act, 2016 for registration of the project "JD BLOSSOM" to which Acknowledgment number was allotted as **ACK/KA/RERA/1251/446/PR/200807/004167**.

On verification, it was found that the applicant has not uploaded project detail, survey numbers, khata, sale deed/title deed, conversion order, JDA, EC, notarized Form B & Joint Affidavit cum Declaration, land owner details, development details, associated vendor details, NOCs from various authorities and affidavit under section 3(1) of RERA Act on the portal. Notices were sent to the promoter on 11/8/2020, 16/10/2020, 4/11/2020, 21/12/2020 and 6/9/2021 for complying with the queries raised therein. Despite several opportunities, the promoter failed to comply with the queries as required.

Hence, final notice for hearing on 18/11/2021 was sent to the promoter on 27/10/2021, as to why this application should not be rejected and an
