3. The promoter of the project has submitted progress reports by the Project Architect, Engineer and Chartered Accountant vide submissions dated 24-11-2021. As per the Certificate of the Chartered Accountant dated 22-11-2021 all the 36 units being constructed are shown as a part of the unsold in entering and the valuation of the same is adopted for the purpose of explaining the requirement of funds for completion of the project. On this hasis, the Applicant-Promoter has submitted that Agreement of Sale have not been entered into with any allottee and no consideration is received so far from any allottee and therefore, the requirement of obtaining two third consents of the allottees is submitted to be waived.
