The Promoter of the project viz., Sri. Muni Reddy had submitted an application for registration of the project viz., "SUVARNA RESIDENCY" vide Acknowledgement No. ACK/KA/RERA/1251/308/pr/180503/002219. The office of the Authority sought submission of documents and clarifications from the Promoter of the project to consider the application for registration of the project. However, the promoter of the project has not responded to the enquiries sent by the Office of the Authority and consequently the application filed seeking registration of the project was not considered by the Authority.

2. It was brought to the notice of the Authority that the said project was not registered with the Authority, although it was required to be registered as an on going project in accordance with the provisions of the Act. The hearing of the case was held on 30-09-2021, during which the promoter of the project personally appeared and admitted that the project was completed without obtaining the registration from the Authority and the apartments have been sold.
