The Promoter BELLEVANA LAYOUT had filed an application dated 04/09/2021 under Section 5(1) of the Real Estate (Regulation and Development) Act, 2016 for registration of the project "BELLIVANA LAYOUT" and the authority issued an Acknowledgment number **ACK/KA/RERA/1268/378/PR/210904/005212**.

On verification, it was noticed that the applicant has not uploaded all the required documents as per Section 4 of the Act read with Rule 3 of Karnataka Real Estate (Regulation and Development) Rules 2017. Notices were sent to the promoter 14/9/2021, 27/9/2021 and 11/10/2021 for complying with the queries raised therein. Despite opportunities given to the promoter, the promoter failed to upload the documents as required.

Hence, final notice for hearing was sent to the promoter on 07/01/2022 to appear for hearing through Skype on 18/01/2022, as to why this

ORDER

In view of the failure on the part of the Applicant-Promoter to comply with the requirements of submitting and uploading the information and documents in accordance with Section 4 of the Act read with Rule 3 of the Rules, and in exercise of the power conferred under section 5(1)(b) of the Real Estate (Regulation and Development) Act, 2016, the application bearing No. **ACK/KA/RERA/1268/378/PR/210904/005212** requesting for registration of the Project by name **"BELLIVANA LAYOUT"** is hereby **rejected** with a liberty to the developer to reapply for registration along with relevant documents. Registration fee is forfeited.
