**O R D E R**

In view of the failure on the part of the Applicant-Promoter to comply with the requirements of submitting and uploading the information and documents in accordance with Section 4 of the Act read with Rule 3 of the Rules, and in exercise of the power conferred under section 5(1)(b) of the Real Estate (Regulation and Development) Act, 2016, the application bearing No. **ACK/KA/RERA/1258/404/PR/210917/005246** requesting for registration of the Project by name **"RAJU KARUR LAYOUT"** is hereby **rejected** with a liberty to the developer to reapply for registration along with relevant documents.
