The Promoters Mr.M.P. Ravi Shankar and Mrs.M.P. Sandhya Rani had filed an application dated 07/10/2021 under Section 5(1) of the Real Estate (Regulation and Development) Act, 2016 for registration of the project "AISHWARYA PARADISE ENCLAVE" and the authority issued an Acknowledgment No. **ACK/KA/RERA/1268/378/PR/211007/005308**.

On verification, it was noticed that the applicant has not uploaded all the required documents as per Section 4 of the Act read with Rule 3 of Karnataka Real Estate (Regulation and Development) Rules 2017. Notices were sent to the promoter on 21/10/2021, 10/11/2021 and 26/11/2021 for complying with the queries raised therein. Despite opportunities given to the promoter, the promoter failed to upload the documents as required.

Hence, final notice for hearing was sent to the promoter on 03/01/2022 to appear for hearing on 05/01/2022, as to why this application should not be

Registration fee is forfeited.
