On verification, it was noticed that the applicant has not uploaded all the required documents as per Section 4 of the Act read with Rule 3 of Karnataka Real Estate (Regulation and Development) Rules 2017. Notices were sent to the promoter on 29/06/2020, 02/11/2020, 20/12/2020 and 07/09/2021 for complying with the queries raised therein. Despite opportunities given to the promoter, the promoter failed to upload the documents as required.

Hence, final notice for hearing was sent to the promoter on 03/01/2022 to appear for hearing on 05/01/2022, as to why this application should not be
