EXECUTION ORDER:

Complaint under Section 31 of RERA Act has been initiated by the complainant Mr. CHANDAN J who is the consumer "PRESTIGE under the project BAGAMANE TEMPLE BELLS" which is "PRESTIGE by **ESTATES** developed LIMITED." This complaint PROJECTS was filed by the complainant claiming Delay Compensation, Interest Payment. After hearing the parties, order was passed on 02/11/2021 by directing the developer to pay delay compensation @ 2% p.a above the MCLR of SBI on the amount received from the Complainant from 01/05/2019 to 29/06/2019.

The complainant has calculated the interest @10.5% p.a. on respective amount paid by him commencing from 01/05/2019 to 29/06/2019 which totally comes to Rs.1,19,719/-.

Total amount due from the developer is Rs.1,19,719/-.

The complainant has given a representation with memo of calculation since the developer failed to comply with the same. There is no appeal. Objections called for but not filed.

As per Rule 25 of the Karnataka Real Estate (Regulation and Development) Rules, 2017 the recovery of the amount due is to be considered as arrears of land revenue. In support of the same the authority is taking the shelter under Section 40 of the RERA Act which reads as follows;

Sec 40(1): "if a promoter or an allottee of a real estate agent, as the case may be, fails to pay any interest or penalty or compensation imposed on him, by the adjudicating officer or the regulatory authority or the appellate authority, as the case may be, under this Act or the rules and regulations made there under, it shall be recoverable from such promoter or allottee or real estate agent, in such manner as may be prescribed as an arrears of land revenue"
