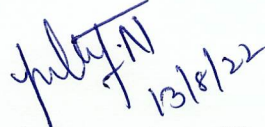

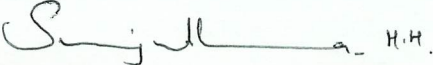
JOINT MEMO

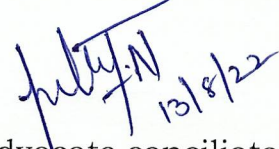
