The judgment has been passed in this case on 03.08.2018. The respondent in a memo dated: 14.12.2020 among others stated that it has complied the direction issued by the Learned Adjudicating Officer (here-in-after referred as AO) by paying Rs. 62,237/- to the complainant. The dispute with regard to execution proceedings in this case was referred to Lok Adalat. Sri. R.K. learned counsel for the complainant had joined in pre Lok Adalat sitting through Skype on 27.09.2622 but respondent did not join in pre Lok Adalat sitting through Skype as directed, as such, parties were directed to appear physically in open court for hearing on 14.10.2022. I have heard Sri. R.K learned counsel for the complainant on the alleged balanced amount payable to the complainant, the respondent was absent, hence respondent's argument taken as heard. The perusal of records discloses that the learned AO (my predecessor) after passing of the judgment/order dated: 03.08.2018 in this case, on considering materials on record, passed the order dated: 30.07.2019 where-under directed respondent to pay the amount of Rs. 62,237/- to the complainant as ordered therein. The respondent in a memo dated: 14.12.2020 among others stated that as per the aforesaid direction of the AO respondent has transferred an amount of Rs. 62,237/- to the bank account of Mr. Manjunatha K. S. and Mrs. Priya M., as stated therein. Sri. R:K. the learned counsel for the complainant admits the
