The appellant has filed the above appeal under Section 44 (1) of the Real Estate (Regulation and Development) Act, 2016, praying to set aside the order dated 13.10.2021 in complaint No. CMP/171016/0000146 passed by the Adjudicating Officer-2nd Respondent.

This appeal, coming on for Orders this day, Hon'ble Administrative Member delivered the following:

JUDGMENT

The appellant, who is an allottee of a site developed by the $1^{\rm st}$ respondent-Housing Society, has preferred this appeal challenging the impugned order dated $13^{\rm th}$ October, 2021 passed by the learned Adjudicating Officer in complaint No. CMP/171016/0000146.

- 2. Respondent No.2 RERA though served remained unrepresented.
- 3. Sri. Manjunath L Naik, appellant, appears as party-in person, Sri. V. Krishna Murthy, learned counsel appears for 1st respondent, Sri. Sheshe Gowda, President of the 1st Respondent is present in the Court. They jointly submit that subsequent to filing of this appeal, Appellant-allottee, Sri. V. Krishna Murthy, learned counsel appearing for 1st respondent and President of the Society, after due deliberation and discussion of their dispute pertaining to Compliant No. CMP/171016/0000146 and this appeal have got settled their dispute by reducing the terms of settlement into writing by filing a Joint Memo,
