After registering the complaint, notices were sent to both the parties. In response to the notices issued, complainant has failed to appear before this Authority, whereas promoter has appeared through his counsel on 18/09/2020 and filed statement of objections on 07/10/2020.

On 22/12/2020 present complaint has been transferred to this Authority on the ground that Adjudicating Officer does not have jurisdiction on the subject matter of the complaint. This Authority has issued further notices to both the parties through mail. Both the parties have not appeared before this Authority. Learned counsel for respon tent filed a Memo dated 27/09/2021 along with order copy in write petition No. 15025 of 2020 (GM-RES) in which the Writ Petition filed by the present complainant came to be dismissed for non-prosecution. Perused the same. The gist of the complaint is that the Complainant is the owner of 7 guntas of land in Sy. No.20 of Basapur village and Respondent No.4, i.e. present promoter has obtained sanction of building plan, which includes the land of the complainant. Learned counsel for respondent No.4, BBMP has submitted before the Hon'ble High Court of Karnataka that BBMP has not sanctioned any plan pertaining to Sy. No. 20 of Basapur Village.

Non-appearance of the complainant is construed as lack of interest on the part of the complainant to pursue this complaint before this Authority. Hence, the following order is passed.
