Respected Sir /Madam

We had filed the above stated complaint on 18th September 2021 before Karnataka Real Estate Regulatory Authority (ICASKA) (Annexure – 1) for the delayed possession of the Unit No. 1114 in Total Environment Habi at Private Limited, Bengaluru ("the Company") upon purchase of Unit No. 1114 in the Company's residential Project Pursuit of a Radical Rhapsody (Phase 01) ("the Project").

We had filed the above complaint as the Unit was not handed over to us as per the date mentioned in the term sheet dated 31st May 2016 and sought the refund of the amount paid towards the Unit. We had also claimed the compensation towards the Unit's completion. As per the Term Sheet the date of Handover of the Unit was 31st March 2019.

The Company has to our utmost satisfaction provided inputs on the said Unit regarding the delay in the Unit's handover and consequently, the parties have agreed to a mutually agreeable date of handover of the Unit. The Company has apprised us that delay was due to the unforeseen circumstances caused by Covid-19 pandemic and an earlier complaint filed by us before the Directorate General of Anti-Profiteering, which has also been withdrawn upon us being satisfied of the resolution provided by the Company therein.

Since there are no outstanding monies to be recovered by the Company, we are withdrawing the complaint made against the Company voluntarily. Kindly oblige and forgive the inconvenience caused to the authority in this regard. Pursuant to the same, we have signed a withdrawal letter with the Developer indicating our intention to withdraw the above captioned complaint, a copy of the same is attached herewith.

We request you to dispose off the complaint as the same is now withdrawn and request your good selves to confirm the same.
