The complainant prays that the common areas which are allocated as parking need to be cancelled in conformity with the approved plan. As the issue raised is a primarily matter for association to consider, it is found appropriate at the juncture to direct the respondent not to allot / sell the common areas and strictly comply with the approved building plan.

Notices were sent to both the parties, to attend hearing on 30/11/2021 on Skype and 11/01/2022 to attend hearing. On 30/11/2021 as were as on 11/01/2022, both the complainants and the respondents were absent.

On a perusal of the complaint, it is seen that the maintenance of the common areas does not seem to have been handed over to the Association of allottees, as required under Section 17 of the Act. However, promoter cannot deny peaceful possession of the parking area to all the allottees by allowing parking in common areas which leads to conflict among the allottees. The Association of allottees is mandated under the Act to regulate the parking areas as well as the common areas.

### ORDER

In exercise of the powers conferred under Section 31 of the Real Estate (Regulation and Development) Act, 2016, the complaint bearing No. CMP/UR/210421/0007913 is hereby allowed. It is ordered that the promoter / developer shall not
