## JUDGMENT / ORDER

FACTS OF THE CASE: The Complainant vide complaint No. CMP/200907/0006484 filed under section 31 of the Act has sought the following reliefs:

- i) Direct the Respondent/s to complete the project and handover the apartment bearing No.001, Tower OAK-C in the Greens Phase-II as promised under various advertisements and Sale Brochures.
- ii) Direct the respondent/s to continue to pay pre-EMI installment until completion of the project.
- iii) Compensation for mental agony and pay the damages to an extent of Rs.5,00,000/-.
- iv) Compensation for unfair trade practice to an extent of Rs.5,00,000/-.
- v) Cost of litigation and expenses to an extent of Rs.50,000/-.
- 2. The Advocate for complainant has filed a Memo dated 29.06.2022 before the Authority for withdrawal of the complaint. In the said memo it is stated that the complainant may be permitted to withdraw the aforesaid complaint in order to file a complaint before Consumer Commission so as to seek the refund of the money and other applicable reliefs. Hence, the Authority passes the following order.

### **ORDER**

The memo submitted by the Advocate for Complainant for withdrawal of the complaint is taken on record and complaint is treated as dismissed.
