This authority has issued notice to both the parties to appear before this authority on 20th May 2022. In pursuance of the notice Vidya Advocate appeared on behalf of respondent. Today the complainant and Respondent have filed Joint Memo before this authority along with Xerox copy of Demand Draft bearing No.963270 dt. 27/09/2022 of HDFC Bank for having received an amount of Rs.3,91,367/- (Rupees Three lakhs Ninety one thousand three hundred sixty seven only) towards the delay in possession as full and final settlement amount by the complaint. The complainant has also appeared personally before this Authority and submitted xerox copy of Adhar card. The xerox copy is verified with the original before this authority.
