The grounds urged provide compensation from the respondent for delayed construction and handover of flat. The complainants have agreed to purchase residential flat in the project RAJA RITZ AVENUE PHASE-I of the respondent.

This authority has issued notice to both the parties to appear before this authority on 22nd September, 2022. In pursuance of the notice Vidya Advocate appeared on behalf of respondent. Today complainant Mr. Mahesh Hebballi for himself and also authorization letter given by Mrs. Rashmi Angadi and Respondent have filed Joint Memo before this authority along with Zerox copy of Demand Draft bearing No. 230127 dt. 31/10/2022 of HDFC Bank for having received an amount of Rs. 3,62,788/- (Rupees Three lakhs Sixty two thousand Seven hundred Eighty Eight only) towards the delay in possession as full and final settlement amount by the complainants. The complainant has also appeared personally before this Authority and submitted xerox copy of Adhar card and Authorisation letter for Mrs. Rashmi Angadi.
