### DOGMENT / ORDER

**FACTS OF THE CASE**: This complaint is filed under Sec-31 of the Real Estate (Regulation and Development) Act, 2016 before this Authority against the project Lapalazzo Residencies praying for reliefs as follows:

 Direct the Respondents to deliver possession of the apartment bearing No.604 on the Fourth Floor in Block Verona. East Terrazo of the Development known as "LA Palazzo Residences" in a reasonable time bound manner as this Hon'ble Authority deems fit;

- 2. Direct the Respondents to accept the payment of Rs. 34,99,316/made by the Complainant towards outstanding dues payable;
- 3. Direct the Respondents to withdraw their claim for interest due on outstanding amounts till date;
- Direct the Respondent to pay the Complainant interest and compensation for delayed delivery of possession apartment Complainant till date as per Karnataka RERA Act;
- 5. Direct the Respondent to demand the next payment due only at the time of the possession. If Respondent has not paid as per relief claimed in point(iv)as above, then demand the next payment after adjusting the amount in point(iv) as above;
- 6. Order for any other relief which this Hon'ble Authority may deem fit and proper in the facts and circumstances of the instant case in favour of the complainant. .

A joint memo dated 13-09-2022 was filed by the Complainant and Respondent signed by their Advocates. The parties here to pray that this Hon'ble Authority may be pleased to dispose off the complaint in terms of the Deed of Settlement date 17-08-2022. Hence, the following order.

#### **ORDER**

The joint memo submitted by the Complainant and Respondent for withdrawal of the complaint is taken on record and complaint is treated as disposed off.
