The grounds urged are that, the complainant has agreed to purchase residential flat in the project RAJA RITZ AVENUE PHASE-I of the respondent. It is further urged that the respondent/builder has to pay the delay compensation from 1st November 2021. As per the agreement the respondent had to be completed the project by 31st January, 2021. But till date the respondent has not given possession.

This authority has issued notice to both the parties to appear before this authority on 20th May, 2022 along with relevant document/s supporting to the complaint. In pursuance of the notice Mrs. Vidya Advocate appeared on behalf of respondent before this authority. Today the complainant and respondent are jointly filed Joint Settlement Memo along with Zerox copy of Demand Draft bearing No.704011 dt. 06/01/2023 of HDFC Bank for having received an amount of Rs.5,06,085/- (Rupees Five lakhs Six thousand Eighty five only) as full and final settlement amount by the complainant. The complainant has also appeared personally before this Authority and submitted zerox copy of Adhar card. The zerox copy is verified with the original before this authority.
