The complainants and the respondent in the above complaint jointly submit as under:

- I. During the pendency of the above complaint, the complainants/allottees and the respondent/promoter after due deliberation have got their dispute pertaining to the subject matter of the complaint settled amicably before the Lok-Adalat.
- 2. In view of the same, they jointly request this Lok Adalat to dispose of the complaint as amicably settled before the Lok Adalat in the following manner.
 - 1. On 25/11/2022 Rs. 95,000/-
 - 2. On 26/12/2022 Rs. 95,000/
 - 3. On 25/01/2023 Rs. 96,204/
 - 4. On 25/02/2023 Rs. 95,000/
 - 5. On 25/03/2023 Rs. 95,000/-
 - 6. On 25/04/2023 Rs. 95,000/

Total amount of Rs.5,71,204/-[Five Lakh Seventy One Thousand Two Hundred four Rupees infavour of the complainant through RTGS/NEFT as a full and final settlement amount towards the said case. Incase of non payment of monthly payment 2% interest shall be payable by the respondent to the complainant. The opposite party is hable to pay Rs. 10,000/- towards cost of the litigation to the complainant towards the said case.

- 3. The claim of the complainants in this complaint is being fully satisfied and complainants have no further claim against respondent in this complaint. Both parties to the proceedings have no claim whatsoever against each other in respect of the subject matter of the above complaint.
