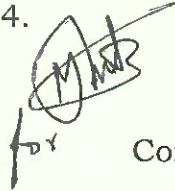
2. In view of the same, they jointly request this Lok-Adalat to dispose of the complaint as amicably settled before the Lok-Adalat.

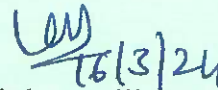

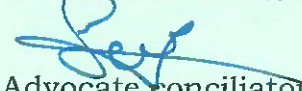
