JOINT MEMO

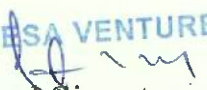
The complainants and the respondent in the above complaint jointly submit as under:

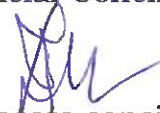

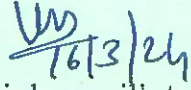

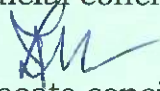
