After hearing the parties, order was passed on 18/11/2019 by directing the developer pay the delay p.a. @9%compensation February 2016 till 30/4/2017 and also directed to pay interest @2% p.a. above the SBI rate marginal lending on homes loans commencing from 1/5/2017 till the possession is delivered after taking the Occupancy Certificate. The developer is also directed to pay Rs. 5000/- as cost. The complainant has given a representation 09/03/2020 to this authority to take action against the developer for recovery of the said amount since the developer failed to comply with the order. On the basis of the representation, notice was issued to the developer calling for his objections through online to submit on or before 12/06/2020 on account of maintaining social distance as per SOP of this authority dated 04.06.2020. According to the said notice the developer has not submitted his objections/reply. Therefore, the matter was posted for orders.
