Complaint under Section 31 of RERA Act has been initiated by the complainant Sandesh Kumar who is the consumer under the project "Aloha" which is developed by "Cubatic Shimul Ventures Pvt. Ltd," This complaint was filed by the complainant claiming to compensation amount. After hearing the parties, order was passed on 5/11/2019 developer is hereby directed to pay the interest @ 2% P.A. above the SBI marginal Lending rate of Interest on home loan commencing from July 2017 till obtaining the Occupancy certificate and delivery of the possession. Further the developer has to pay Rs. 5,000/-towards cost of petition.

The complainant has given a representation on 06/02/2020 to this authority to take action against the developer for recovery of the said amount since the developer failed to comply with the order.

On the basis of the representation, notice was issued to the developer to appear before the Adjudicating Officer on 25/2/2020, The complainant was present and the developer was not present and failed to return the amount Therefore, the matter was posted for orders.

As per Rule 25 of the Karnataka Real Estate (Regulation and Development) Rules, 2017 the recovery of the amount due is to be considered as arrears of land revenue. In support of the same the authority is

taking the shelter under Section 40 of the RERA Act which reads as follows;

Scc 40(1): "if a promoter or an allottee of a real estate agent, as the case may be, fails to pay any interest or penalty or compensation imposed on him, by the adjudicating officer or the regulatory authority or the appellate authority, as the case may be, under this Act or the rules and regulations made there under, it shall be recoverable from such promoter or allottee or real estate agent, in such manner as may be prescribed as an arrears of land revenue"

When Sec. 40 read with Rule 25, the Deputy Commissioner is empowered to execute the order dated 5/11/2019 considering this amount as arrears of land revenue and has to be recovered from the developer. Hence the following order:-

ORDER

By acting under Section 40 of the RERA Act, read with Rule 25, the amount payable of Rs.90,51,358/- which treated as arrears of land revenue from the developer "Cubatic Shimul Ventures Pvt. Ltd," and the same has to be recovered by sending the file to Deputy Commissioner for recovery as arrears of land revenue. The same amount shall be deposited in the office Account.
