Complaint under Section 31 of RERA Act has been initiated by the complainant Avinash. S who is the consumer under the project "Unishire Premia" which is developed by "Unishire Skyscapes LLP," This complaint was filed by the complainant claiming for Delay Compensation. After hearing the parties, order was passed on 19/01/2019 by directing the developer to pay delay compensation in the form of interest @10.75% commencing from March 2017 till the notice of possession is issued.

The complainant has given a representation on 25/02/2020 to this authority to take action against the developer for recovery of the said amount since the developer failed to comply with the order.

On the basis of the representation, notice was issued to the developer calling for his objections through online to submit on or before 12/06/2020 on account of maintaining social distance as per SOP of this authority dated 04.06.2020. According to the said notice the developer has not submitted his objections/reply. Therefore, the matter was posted for orders.

As per Rule 25 of the Karnataka Real Estate (Regulation and Development) Rules, 2017 the recovery of the amount due is to be considered as arrears of land revenue. In support of the same the authority is taking the shelter under Section 40 of the RERA Act which reads as follows;

Sec 40(1): "if a promoter or an allottee of a real estate agent, as the case may be, fails to pay any interest or penalty or compensation imposed on him, by the adjudicating officer or the regulatory authority or the appellate authority, as the case may be, under this Act or the rules and regulations made there under, it shall be recoverable from such promoter or allottee or real estate agent, in such manner as may be prescribed as an arrears of land revenue"

When Sec. 40 read with Rule 25, the Deputy Commissioner is empowered to execute the order dated 19/01/2019 considering this amount as arrears of land revenue and has to be recovered from the developer. Hence the following order:-
