Complaint under Section 31 of RERA Act has been initiated by the complainant Sujit Kumar Sahoo who is the consumer under the project "Nivasa" which is developed by "Namma Manc Housing LLP." This complaint was filed by the complainant claiming refund of money with interest. After hearing the parties, order was passed on 16/10/2019. Complaint No.3268 is closed. The developer is hereby directed to obey the conditions as mentioned in the settlement memo dated 06/09/2019.

The complainant has given a representation on 20/12/2019 to this authority to take action against the developer for recovery of the said amount since the developer failed to comply with the order.

On the basis of the representation, notice was issued to the developer to appear before the Adjudicating Officer on 24/1/2019,. The complainant was present and the developer was present but failed to return the amount. Therefore, the matter was posted for orders.

As per Rule 25 of the Karnataka Real Estate (Regulation and Development) Rules, 2017 the recovery of the amount due is to be considered as arrears of land revenue. In support of the same the authority is

taking the shelter under Section 40 of the RERA Act which reads as follows;

Sec 40(1): "if a promoter or an allottee of a real estate agent, as the case may be, fails to pay any interest or penalty or compensation imposed on him, by the adjudicating officer or the regulatory authority or the appellate authority, as the case may be, under this Act or the rules and regulations made there under, it shall be recoverable from such promoter or allottee or real estate agent, in such manner as may be prescribed as an arrears of land revenue"

When Sec. 40 read with Rule 25, the Deputy Commissioner is empowered to execute the order dated 16/10/2019 considering this amount as arrears of land revenue and has to be recovered from the developer. Hence the following order:-

ORDER

12.

By acting under Section 40 of the RERA Act, read with Rule 25, the amount payable of Rs36,73,099 /- which treated as arrears of land revenue from the developer "Namma Mane Housing LLP," and the same has to be recovered by sending the file to Deputy Commissioner for recovery as arrears of land revenue. The same amount shall be deposited in the office Account. (For attachment of property address is attached with this order).
