Complaint under Section 31 of RERA Act has been initiated by the complainant Sanket Kumar Roy who is the consumer under the project "Radiant Elitaire" which is developed by "Radiant Structure Pvt.Ltd," This complaint was filed by the complainant claiming compensation. After hearing the parties, order was passed on 26/12/2018by directing the developer pay the delay compensation @10.25% on the amount paid by him from January 2018 till the notice for delivery of possession is issued along with O.C

The complainant has given a representation on 02/12/2019 to this authority to take action against the developer for recovery of the said amount since the developer failed to comply with the order.

On the basis of the representation, notice was issued to the developer to appear before the Adjudicating Officer on 24/01/2020, Both the parties were not present Therefore, the matter was posted for orders.

As per Rule 25 of the Karnataka Real Estate (Regulation and Development) Rules, 2017 the recovery of the amount due is to be considered as arrears of land revenue. In support of the same the authority is
