Project started in April 2012. Delay in completion of project of by over 27 months excluding the Grace period as per contract. Builder not taking any initiative even after buyers paying ahead of schedule and showing all support.

Relief Sought from RERA:

Early completion of Refund with Penalty & Interest interim order Required:

The complainant is represented by his advocate Rihabha Raj Thakur and the developer is represented by his advocate Sri R. Muralidhar.
