Complaint under Section 31 of RERA Act has been initiated by the complainant Siddharth Ramesh Pawer who is the consumer under the project "Unishire Weave" which is developed by "Unishire Promoters Pvt. Ltd.," This complaint was filed by the complainant claiming to Delay Compensation. After hearing the parties, order was passed on 19/07/2019 The developer is directed to return Rs.1,78,495/-The developer is also directed to pay interest on Rs.5,36,495/- @ 9% prior to 30/04/2017 and @ 10.25% from 01/05/2017 till the realization. The developer is also directed to discharge the loan amount.

The complainant has given a representation on 12/12/2019 to this authority to take action against the developer for recovery of the said amount since the developer failed to comply with the order.

On the basis of the representation, notice was issued to the developer to appear before the Adjudicating Officer on 3/1/2020, both the parties were present but the developer failed to return the amount. Therefore, the matter was posted for orders.

As per Rule 25 of the Karnataka Real Estate (Regulation and Development) Rules, 2017 the recovery of the amount due is to be considered as arrears of land revenue. In support of the same the authority is

Hence the following order:- ORDER By acting under Section 40 of the RERA Act, read with Rule 25, the amount payable of Rs.32,42,141/-which treated as arrears of land revenue from the developer "Unishire Promoters Pvt. Ltd.,." and the same has to be recovered by sending the file to Deputy Commissioner for recovery as arrears of land revenue. The same amount shall be deposited in the office Account.
