Dear Sir, As per the construction agreement dated, 5th October 2016, the builder Vasathi housing Ltd was to complete construction and hand over the flat, C-806, by June 2017. However the flat is yet to be handed over and the construction seems to have been at a very slow pace despite of repetitive follow ups. This delay of 16 months (inclusive of 6 months grace period) have caused significant inconvenience to me and my family. To add to our woes, the builder has been neglecting the promised delay compensations as well. As such, I request RERA to help me procuring the Delay compensation which should be calculated at 12% PA from 01 Jan 2018 till date of handingover on the total amount paid to the builder. Along with the same the interest part( @18% which is what builder will charge if
